

## **Goleta Sanitary District Job Description**

**Job Title:** Wastewater Treatment Plant Operator-In-Training III  
**Department:** Plant Operations  
**Reports To:** Operations Supervisor  
**FLSA Status:** Non-Exempt (Non-Salary)

### **SUMMARY**

Under direct supervision, monitors wastewater treatment plant processes; performs routine laboratory tests and a variety of duties in the cleaning, maintenance and operation of a wastewater treatment plant. Employees in this job classification may progress to the WWTP Operator III position once they have mastered the full range of duties performed by a Plant Operator II and have obtained their Grade III Wastewater Treatment Plant Operators Certificate.

### **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

Participate in assigned treatment plant rounds including inspecting, monitoring and documenting plant operations by reading plant equipment gauges, graphs and other instruments.

Observe variations in operating conditions and interprets meter and gauge readings and tests results to determine treatment process condition.

Assist in monitoring control panels and adjusts valves and gates manually or by remote control to regulate treatment process flows, including starting and stopping pumps, engines, and generators to control flow of wastewater through filtering, settling, aeration, and sludge digestion processes.

Maintain, compile and update operations log and reports. Perform and record mathematical calculations related to plant operational activities under supervision.

Assist in maintaining, installing, repairing and servicing plant process equipment, including pumps, valves, motors, meters and other equipment.

Monitor and maintains chemical feed equipment and chemical inventories used in the treatment process

Operation of motorized equipment such as front-end loaders, forklifts, articulated wheel loaders and dump trucks.

Collects wastewater samples and conducts routine laboratory tests.

Other duties may be assigned.

## **QUALIFICATIONS**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

**Knowledge Of:** Methods of treatment processes used in a wastewater treatment plant; principle, practices, methods and procedures used in the operation and maintenance of a wastewater treatment plant. A working knowledge of the tools and practices used in plumbing and mechanical trades are desired.

**Ability To:** Operate and maintain the full range of equipment commonly found in wastewater treatment plants; monitor and maintain plant processes; conduct laboratory tests and analysis; read and interpret gauges and recording devices monitoring plant operations; operate motorized equipment used in plant operations; establish and maintain effective working relationships with those encountered in the course of work. Work in confined spaces and use self-contained breathing apparatus and respirators.

## **EDUCATION and/or EXPERIENCE**

High school diploma or equivalent and 12 educational points and 18 months of full-time qualifying experience as a California State Water Resources Control Board (CSWRCB) Certified Grade II operator. Or, High school diploma and 18 educational points and 30 months of full-time qualifying experience as a CSWRCB Certified Grade I operator. Or, an Associate's degree or a minimum of 60 college semester units, including a minimum of 15 semester units of science courses. Or, a Bachelor's or higher degree, including a minimum of 30 semester units of science courses.

Obtain American Red Cross First Aid and Cardiopulmonary Resuscitation (CPR) certificates within 6 months from date of hire.

## **LANGUAGE SKILLS**

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports, logbook entries and correspondence. Ability to speak effectively before groups of customers or employees of the District.

## **MATHEMATICAL SKILLS**

Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent and to draw and interpret graphs.

## **REASONING ABILITY**

Ability to apply common sense understanding to carry out detailed but uninvolved written or oral instructions. Ability to deal with problems involving a few concrete

variables in standardized situations.

### **CERTIFICATES, LICENSES, REGISTRATIONS**

Possession of a valid California Class C driving license with a satisfactory driving record.

Must be able to obtain a Wastewater Treatment Plant Operator III certification within 12 months.

Ability to obtain American Red Cross First Aid and Cardiopulmonary Resuscitation (CPR) certificates.

### **PHYSICAL DEMANDS**

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to stand, walk, and talk or hear. The employee frequently is required to use hands to finger, handle, or feel; reach with hands and arms; climb or balance; and smell. The employee is occasionally required to sit and stoop, kneel, crouch, or crawl. The employee must regularly lift and/or move up to 25 pounds, frequently lift and/or move up to 50 pounds, and occasionally lift and/or move up to 75 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and ability to adjust focus.

The employee is occasionally required to work in confined spaces or other areas with potentially hazardous atmospheres requiring the use of self-contained breathing apparatus (SCBA) or respirators and in that respect is required to follow the District's facial hair policy.

### **MENTAL DEMANDS**

While performing the duties of this class, employees are regularly required to use oral and written communication skill; read documents or instructions; analyze and solve problems; observe and interpret data or information; use math and mathematical reasoning; learn and apply new information or skills; Work under constantly changing deadlines and priorities with constant interruptions.

### **WORK ENVIRONMENT**

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly exposed to moving mechanical parts, fumes or airborne particles, and outside weather conditions. The employee is frequently exposed to wet and/or humid conditions; high, precarious places; toxic or caustic chemicals; and risk of electrical shock. The employee is occasionally exposed to vibration. The noise level in the work environment is usually moderate.
