#### SUMMARY

Inspects industrial and commercial waste disposal facilities and investigates source of pollutants in municipal sewage system to ensure conformance with ordinance and permit requirements by performing the following duties.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. Other duties may be assigned.

Visits establishments to determine possession of industrial waste permits and to inspect waste treatment facilities such as floor drains, sand traps, settling and neutralizing tanks, and grease removal equipment for conformance with regulations.

Collects wastewater samples from industrial plants, sewers, commercial establishments, and institutional facilities.

Investigates and traces sources of undesirable industrial wastes.

Performs testing and interprets results of chemical, biological, and physical analysis of wastewater, treatment chemicals and related materials.

Operates computer system utilizing word processing and spreadsheet programs.

Conducts field tests for acidity, alkalinity, and other characteristics to determine if discharged wastes will cause water pollution or deterioration of sewerage facilities.

Prepares correspondence and quarterly and annual monitoring reports for state and federal regulatory agencies.

Inspects sewers to determine presence of pollutants and explosive gases.

Reviews plans of proposed waste treatment facilities and inspects construction to ensure conformance with ordinances.

Issues citations to apparent violators of sanitation code or water quality regulations.

Compiles written reports of investigations and findings, and actions taken or recommended.

Enforces ordinances concerned with commercial hauling and disposal of contents from grease interceptors.

Inspects groundwater remediation sites for contamination and conformance with discharge standards.

## QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. **Knowledge Of:** Considerable knowledge of chemistry, biology, and microbiology pertaining to laboratory procedures associated with wastewater treatment plant operations; federal, state and local laws and regulations pertaining to industrial waste and wastewater treatment systems; methods and techniques used in sampling and testing industrial, commercial ,and domestic wastes and treatment process flows; safety precautions required when working with laboratory equipment, chemicals, machinery, and toxic wastes; wastewater treatment processes and industrial discharge and collection systems.

# Ability To:

Plan, organize, and direct the operation of an industrial waste inspection program; install, operate, and maintain sample and test records and files; efficiently utilize computerized word processing and spreadsheet programs; collect samples, analyze and interpret test results; perform a variety of laboratory tests accurately; communicate clearly and concisely, both orally and in writing; establish and maintain effective relationships with those contacted in the course of work; maintain mental capacity which allows the capability of making sound decisions and demonstrating intellectual capabilities; maintain effective audio/visual discrimination and perception to the degree necessary for the successful performance of assigned duties.

# **EDUCATION and/or EXPERIENCE**

Bachelor degree in Chemistry, Environmental Studies or related science and one year experience in the wastewater operations or laboratory. An equivalent combination of education and experience may be considered.

# LANGUAGE SKILLS

Ability to read, analyze, and interpret periodicals, professional journals, technical procedures, or governmental regulations. Ability to write reports, business correspondence, and procedure manuals. Ability to effectively present information and respond to questions from groups, business owners and managers, customers, and the general public.

#### PHYSICAL DEMANDS
